The Engagement

The client was experiencing issues with their legacy Dynamics AX 2012 R3 system. Korcomptenz stepped in to manage the project, working closely with the client to address all business requirements effectively. We ensured clear sign-offs from business users, optimized system performance, and maintained business continuity throughout each phase of the solution delivery.

Challenges

When Korcomptenz took over the project, we identified several critical areas requiring immediate attention. Additionally, unresolved finance and integration issues, along with poor system performance, were significant pain points. 
